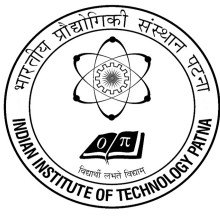

01. **EMD:** Rs. 3,510/- to be deposited in the institute's account through SBI i collect and the receipt of submission is to be uploaded along other techno financial documents. 02. **GST Certificates:** Agency should have GST certificate.
03. The accepting authority reserves the right to reject any or all the quotations without assigning any reason thereof and does not bind him to accept the lowest quotations.
04. **Refund of EMD:** The EMD of the unsuccessful bidder will be discharged /returned to the bidder without any interest whatsoever at the earliest after evaluation of the bid and latest on or before 30 days after the award of the contract. The successful bidder's EMD shall not be discharged until the work/supply is completed and the EMD shall be held as performance guarantee as mentioned in the tender
05. **Forfeiture of EMD:** The EMD shall be forfeited in case :
  - If a bidder intentionally withdraws his bid during the period of bid validity
  - If the bidder violates any of the provision or terms and conditions of the bid
  - If the Bidder alters its Bids during the Bid Validity Period;

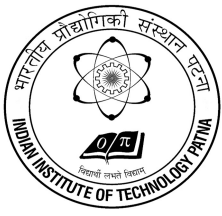
- c. The Successful bidder shall raise the final invoice towards remuneration and other / statutory payments, reimbursements, service charges and retain the service charges only and shall release the payment on monthly basis to the outsourced manpower after deducting necessary TDS, if applicable.
08. **STATUTORY DEDUCTION:** The successful bidder shall ensure that any statutory deductions like PF/ESI are deposited within the time prescribed and AIC do not assume any responsibility in this regard. Similarly, the bidder shall ensure the continuity of all policies including GMP & GPA during the subsistence of the contract period.

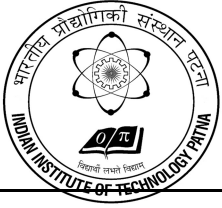

## **DESCRIPTION OF WORKS FOR WHICH MANPOWER IS REQUIRED**

**JOB 01: Opening of concertina coil for a length of 540 meters**

**JOB 02: Fitting of angle of size (50\*50\*3) mm of length 1.75 mtrs for 386 nos of steel columns and zamming of the same with concrete of grade 1:1.5:3 in coping and welding with the present MS angle**

**JOB 03: Cutting of Y MS section from its present location by breaking of welding with other MS member and fixing of the same to the MS member at top by welding**

**JOB 04: Fixing of MS corrugated sheet of width 3'6" and length 14" with overlapping with the existing sheet and providing of J hooks at 4 positions and MS screws at 5 positions for one sheet for a length of 540 meters (Fixing of 125 nos of sheet ) (Sheet to be fixed from inner side of boundary wall)**

**JOB 05: Providing of concertina coil in loops with fixing the same with angles and sheet from inner side of boundary wall**
