This is with reference to our Tender ID: **2024_IITP_833449_1 (Tender No.: IITP/ADMIN/HR/2024/01/1643 Dated 04/11/2024)** regarding “Supply of Human Resources” (Unskilled/Semi-Skilled/Skilled/High-Skilled) and to Undertake Miscellaneous Jobs Under Job Contract/ Outsourcing Mode at IIT Patna (Bihta Campus). The following amendment is made as per details given below:

01. Page No. 08 **For**

Affidavit as per Annexure-E. The company / firm / agency should neither be currently (as on date of bid submission) black-listed / debarred / prohibited /non-performing reported by Central / State Govt. / PSUs Autonomous Bodies of Central or State Govt. including higher educational institutions / central research organizations nor in the last three financial years i.e. **2021-22, 2022-23 & 2023-24.** But previous debarment (if any) should be disclosed in the affidavit. The firm has to proactively disclose any debarment/ blacklisting even if it is sub-judice while submitting the bid and at any stage thereafter. Suppression of such fact, shall lead to rejection of bid or cancellation of order, if awarded besides forfeiture of EMD/Performance Security in addition to the penalty as deemed fit under rule.

Affidavit as per Annexure-E. The company / firm / agency should **not** be black-listed / debarred / prohibited /non-performing reported by Central / State Govt. / PSUs Autonomous Bodies of Central or State Govt. including higher educational institutions / central research organizations, **on the date of bid submission as per GFR 151 and O.M. F.1/20/2018-PPD dt. 02/11/2021 issued by Dept. of Expenditure.** But previous debarment (if any) should be disclosed in the affidavit. The firm has to proactively disclose any debarment/ blacklisting even if it is sub-judice while submitting the bid and at any stage thereafter. Suppression of such fact, shall lead to rejection of bid or cancellation of order, if awarded, besides forfeiture of EMD/Performance Security in addition to the penalty as deemed fit under rule.

02. Closing date of bid submission is extended till 16.12.2024 (15:00 hrs.)

03. Tie breaking criteria: In case there is tie among bidders in **final bid score**, tie breaking criteria shall be adopted in following order:

- (i) Bidder securing higher technical score
- (ii) Bidder having higher average turnover during F.Y. 21-22, 22-23 & 23-24.
- (iii) Bidder having more experience on or after 01.01.2020.

All the other terms and condition of the Tender documents will remain unchanged.
